INTRODUCTION

A comprehensive and sustainable parks and recreation system is vital not only to a community's health, but also for the preventive protection of its citizens, natural resources, and economics. Well-designed parks are known to act as crime and accident prevention. These designated portions of cities also serve environmental needs by enhancing stormwater management, increasing biodiversity and providing cleaner air. Parks are a driving force of economic opportunities. Sports and recreational facilities that attract visitors, team tournaments and tourists increase city tax revenues and ramp up economic vitality. New parks also make the city more attractive to businesses and increase property values.

Before any recreation plan is adopted and enacted, it is first important to understand the needs of the community and its residents, what recreational opportunities already exist and what future projects and programs are relevant to the residents of the city. This is based on age, ability, population, density and the availability of recreation in the surrounding communities. This input is a critical component of this plan, and the city has united to develop a recreation plan to enhance the quality of life for everyone in the city.

The foundation for the development of the Bad Axe Area Recreation Plan is based on the following goals:

- Involve the community in the process to develop a five-year Recreation Plan.
- Inventory and map existing Bad Axe recreational facilities,
- Build common ground among Bad Axe area stakeholders in addressing the future recreational needs and priorities of the Community,
- Enable the City to be eligible for financial assistance based upon the Recreation Plan,
- Facilitate interagency collaboration in establishing recreation goals, objectives, and actions,
- Consistency with and expansion upon goals and objectives set forth in existing planning documents that deal partially or wholly with recreation.

This plan begins with a community description to better understand the landscape and demographics of the City of Bad Axe. The administrative structure is then outlined which describes the governmental and jurisdictional methods by which future decisions will be made. This is followed by the existing recreation inventory which describes all existing City owned parks as well as other local and regional recreation opportunities. This section is followed by the natural resource inventory with any relevant land and water information. Then a description of the planning and public input process, public notifications, survey, and workshop which were used in determining where improvements are needed. This is followed by a series of goals and objectives that were established using recommended planning methods. The goals and objectives are followed by an action program describing recommended improvements and proposed projects in the form of narratives, charts, and maps. And lastly, the appendix holds the support documentation of the survey, public notices, and local adoption which includes minutes and resolutions by the approving bodies.


The newly revised Recreation Plan intended use is to guide the Bad Axe officials on all future recreational and parks projects within the City of Bad Axe. A five-year, MDNR-approved Recreation Plan is necessary for the government entities to pursue MDNR-administered grants. This plan is written for the City of Bad Axe, and it covers all aspects of park facilities and recreation within the community from January 2026 to December 31, 2030. It identifies attainable goals and objectives as well as an action plan that can then be used to focus on key areas for more specific design and budgetary purposes. It has been created under the guidelines established by the Michigan Department of Natural Resources Grants Management and in accordance with The Guidelines for Community Park, Recreation, Open Space and Greenway Plans published by the Michigan Department of Natural Resources (MDNR).

Community Description

Location & City History

The City of Bad Axe is situated in the middle of Huron County in the U.S. state of Michigan and serves as the county seat. Huron County is uniquely located at the tip of the "Thumb" of the mitten that represents Michigan's lower peninsula. The "Thumb" is an eastern portion of the Central Michigan region that is geographically distinguished by the Saginaw Bay of Lake Huron. Therefore, with the expectation of its southern border, Huron County is surrounded by this Great Lake. An intersection between two Michigan highways, M-53 and M-142, occurs in the middle of the City of Bad Axe. These routes account for a large majority of traffic into and within the city. This city is approximately 100 miles north of Pontiac and 50 miles east of Bay City.


The region of present-day Huron County was previously home to the Wyandot people, also known as the Huron Tribe. Euro settlers then began to utilize the area for trapping and fishing. Bad Axe's origins lead back to the 1860s when a military surveyor, Captain Rudolph Papst, coined "Bad Axe Camp" on his charts. This name is supposedly in reference to an old axe left in the camp by hunters. The area surrounding this camp was found to sustain rich, easily drainable soil, making it a favorable location for agriculture. As such the original "Bad Axe Camp" became a permanent community and multiple business endeavors such as lumber and mill operations grew the population. During an annual session of Huron County's Board of Supervisors in October 1872, Bad Axe was declared the county-seat. On March 15, 1905, Bad Axe became independent from the jurisdiction of the two townships, Verona and Colfax, which it is located in. This full administrative autonomy distinguished Bad Axe as Huron County's first city. (https://genealogytrails.com/mich/huron/historybadaxe.html)

Social Characteristics

Population

The current population of Bad Axe is 2,951, showing a decrease since 2010. The County (30,617) is experiencing a similar decrease. This compares to the state's increase of 3.18% giving them a current population of 10,197,600.

Median Age

While the overall population is the most important consideration, there are other characteristics to consider when planning for a community's recreation. The age distribution of a community influences the types of facilities and programs needed. Table 2-2 shows that according to 2023: ACS 5-Year Estimates Subject Tables, the city's current median age (49.0) is slightly lower than the County (49.4). Both the city and the county average ages are significantly higher than the State of Michigan average (40.5). These higher averages suggest that this county has an older age base than the rest of the state. Of course, the city should not ignore the other age groups since they still comprise a large proportion of the overall population.

Younger Population, < 18 yrs old

The median age offers a glimpse into the age distribution of a specified population while other percentages can give more context. Understanding the younger population of a community is essential to developing a recreational plan. Due to physical and mental limitations, the younger population needs specialized infrastructure within a community.

The percentage of the younger population in Bad Axe reflects the trends found above in Table 2-2. The current percentage of younger population (15.7%) has significantly decreased between 2010-2023 (-21.89%). This downward trend also appears in Huron County and Michigan, however the percent change between 2010-2023 is less drastic (-9.43%) and (-14.57%) respectfully. These findings do not suggest that the city should neglect recreational infrastructure catered to this group.

Older Population, > 65 yrs old

The percentage of the older population, as explained above, also provides context to the city's median age. Community members who are 65 years old and older need extra consideration when developing a recreational plan. This group has a higher chance of needing specialized infrastructure to accommodate physical and mental limitations.

According to the 2023 ACS 5-Year Estimates Subject Tables, Bad Axe's current percentage of older population (26.5%) closely resembles that of Huron County as a whole (26.6%). These percentages are notably higher than the state of Michigan's (19.3%). Bad Axe's percentage of older population also reflects the trend found in Table 2-2. Between 2010 and 2023 this percentage in Bad Axe has increased (7.29%). This trend is even more apparent in Huron County (25.47%) and Michigan (39.86%) between 2010-2023.

Household Size

Another important portion of a community to consider is household size. This size offers insight into a city's familial connections and distribution of residential density.

In accordance with the data provided by 2023 ACS 5-Year Estimates Data Profiles, the city's current average household size (2.05) is lower than both Huron County (2.22) and the state (2.39). All three of the % Change between 2022 to 2023 for these regions are decreasing, with Bad Axe's being the highest rate of decrease (-5.53%).

Physical Characteristics

Climate

Bad Axe's humid continental climate is closely related to its geographic relation to Lake Huron. Its winters are relatively mild with average temperatures of mid 20s Fahrenheit, with lows in the single digits in January. Winters, like most of Michigan, consist of common snowfall with a city average of 44 inches of snow per year. Spring and summer are prone to thunderstorms, contributing to the city's average 33 inches of rain. Throughout summers in Bad Axe, the temperatures average around mid-70s Fahrenheit. The highest temperatures occur during July, when temperatures reach mid-80s Fahrenheit.

This climate is very relevant considering how it impacts year-round activities in this city. During the wintertime community members can cross-country ski and snowshoe but are unable to do other outdoor sports like golf. In summer, activities like hiking and biking are common throughout the city.



Transportation Network

The City of Bad Axe has access to state highways such as M-142, M-19, and M-53, which allows for transportation within the city. These highways also serve as well as major routes to areas around and outside of the Thumb region. The city's residents may also use the Thumb Area Transit which offers door-to-door transportation around Huron County.

This city also hosts the Huron County Memorial Airport, which is near the southern border of the city. It is a public owned and used airport. This airport uses and maintains four runways, ranging from 1065' by 23' to 5000' by 75' in dimension. (www.airnav.com/airport/KBAX)

The rest of the roads in the city not previously mentioned in this section are considered local roads that reach across the community.



Utilities Services

Electric Department

The main electrical department for Bad Axe is operated by Maurer Electric, who specializes in residential electrical services. They have an office located in the western central portion of town, along M-53. They are not the only electric providers and community members are able to compare service rates to Consumers Energy and other local electric utility companies.

Water Supply

Sense 2006, the City of Bad Axe get its drinking water from the Huron Regional Water Authority (HRWA). This system will be described at greater length in the next section. The city also maintains a single 265' deep well that draws water from bedrock and Marshall Sandstone aquifers as an emergency back up to the HRWA water system.

The city is transparent to the community members about the testing done on these water supply systems. The city's water is routinely tested for over 80 contaminants, and the results are published in reports available to the public (www.cityofbadaxe.com/images/PDFgen/DPW/Water-Report-2022.pdf).



Wastewater Treatment Facility

In the 1990s, a joint effect between the Village of Port Austin and the City of Bad Axe developed the HRWA. The 10-year project developed a water treatment plant in Port Austin that treats surface water from Lake Huron. This plant and distribution system currently provides water to the municipalities of the City of East Tawas, City of Tawas City, Charter Township of Oscoda, Charter Township of AuSable and Township of Baldwin.

Between the plant and Bad Axe there is a major pipeline running north-south along M-53, with three pumping stations to overcome the elevation difference along the way. Other infrastructure that supports this distribution system includes a 500,000-gallon and a 300,000-gallon water tower as well as the city's water main. This system is operated by F&V Operations. Residents of Bad Axe contribute to the upkeep of this system in their utility bill.

Community Services

Police Department

The Bad Axe Police Department is located in the middle of the city at 110 S Hanselman St, Bad Axe, MI 48413. This location is open from 8 a.m. - 4 p.m. Monday through Friday. The department is responsible for the enforcement of law and order within the city. Community members are also able to assist in this effort through a Neighborhood Watch.

Fire Department

The non-profit organization Bad Axe Area Fire Department is located at 420 S Hanselman St, Bad Axe, MI 48413. This group includes firefighters, EMTs, and paramedics that offer fire suppression, as well as rescue operations. They also serve the community by upholding fire prevention education services.

Ambulance Services

The Central Huron Ambulance Service Association provides quality and timely emergency medical care and transportation throughout Huron County. They work closely with McLaren Thumb Region Hospital, Beach Hospital, Scheurer Hospital, and multiple surrounding EMS agencies to ensure all regions of Huron County are covered.

Public Library


All community members of Bad Axe MI can utilize the Bad Axe Area District Library which consists of over 36,000 physical items, including books, magazines, audio books, video games, DVDs, and newspapers. They also offer a collection of 40,000 digital media options. This library is located at 200 South Hanselman Street Bad Axe, MI 48413. They are financially supported in part by the Institute of Museum and Library Services.






Land Use

The map below identifies the land use patterns within the city as part of the Zoning Ordinance. As seen below, the northern portion of the city is currently being used for neighborhood businesses and residential. The middle of the city is a conglomerate of uses while the southern portion of the city is designated to industrial use. The largest majority of the city is designated as residential.







Administrative Structure


City Administration

The City Council has 7 members including the Mayor and the Mayor Pro-Tem. They adopt and amend City Laws and ordinances, determine City policies and standards, and authorize the annual city budget. The Council also approves contracts and agreements, determines city tax millage rates, determines utility rates, and directs the City Manager. The City Manager is responsible for the day-to-day operations of the City and is the chief policy advisor to the City Council. They also handle the day-to-day administrative functions of parks and Recreation.

The members of the Parks and Recreation Committee are appointed by the City Council. They serve in an advisory capacity only for the council. There are currently 3 members on this committee. They serve 2-year terms and meet quarterly with the Mayor and Mayor Pro-Tem.

The seasonal DPW employee is the only full-time position in the Parks Department in Bad Axe. A seasonal maintenance person is hired for the summertime. Additional positions such as Director and summer day camp staff are also hired as seasonal and temporary.

The following chart illustrates the relationship among the various entities involved in recreation within the City. The administrative structure is as follows:



Budgets

Sources of funding for parks and recreation functions in Bad Axe are from the City general fund, user fees, facility rentals, and local donations. Budgets for 2025-2026 are shown below in the Table.

The general fund budget for the Parks and Recreation Advisory Committee is developed by the City Manager in association with the City Council for annual approval.

Relationships with School Districts and Other Public Agencies or Private Organizations

The Bad Axe Public School District has adopted this recreation plan. In addition, the Committee works closely with the Bad Axe School District to share facilities or programming. The City uses the school football fields for its youth tackle football program and it uses the Junior High Gymnasium for its men's basketball league. The Parks and Recreation Department also works with the Bad Axe Historical Society to coordinate usage of the Log Cabin Village. Lastly, the City works with a group of volunteer parents that organize and run the summer youth baseball program. The City provides the fields for this league.

Volunteers

The Parks and Recreation Department uses approximately 75-100 volunteers each year to assist with all events and programs. Many volunteers work at the Bad Axe Hatchet Festival, which is organized by the Bad Axe Chamber. Other volunteers serve as coaches and referees. Still others assist with maintenance, card nights, trips, community center activities, day camps, fund-raisers, and park cleanup.




Recreational Inventory

An essential element of a recreation plan is the inventory of local and regional, public and private recreation facilities that are available to a community's resident. Within the City of Bad Axe there are parks with many amenities such as playgrounds, ball diamonds, outdoor basketball courts, and picnic areas. This city also hosts facilities that support activities associated with 4-H, engagement events, and specialized sports. This inventory will encompass those parks to provide a basis from which a comparison can be made of existing recreation opportunities with the community's identified recreation needs.

This inventory process also identifies barrier-free facilities. This will ensure that citizens with disabilities will fully enjoy these facilities. Involving advocate organizations and utilizing the knowledge of the city staff will help facilitate this element of the inventory process. Further, this facility inventory establishes the foundation from which a recreational improvement program can be developed and implemented.

City Recreational Facilities

The City of Bad Axe has numerous different recreational opportunities that include the three city owned parks that will be described below. The city upholds these parks for community members to benefit from so the purpose and condition of these current parks will be explored. A parcel of vacant land owned by the City is shown below as area "D". Recreational use is to be explored further.

Bad Axe City Park

This park, as seen in the map above, is located at the southeast region of the city. It is the largest city owned park, spanning 25 acres in total. The northern rectangle is a central hub within the park. It hosts the park's pavilion, picnic area, playground, and one of the porta potties, making it an area ideal for families and gatherings. Much of this park offers natural beauty from the floral landscaping and the many old trees that provide shade.

Bad Axe City Park has the following features:

- 1 pavilion
- 1 playground
- 2 tennis courts
- Walking Path
- Splash Pad
- Skate Park
- Multiuse Field











This northern portion of the park also includes the only parking spaces associated with the Bad Axe City Park. This strip of angled parking has 32 spots for visitors to utilize. Of the total parking spaces, four are marked and dimensioned as barrier free. Two of these parking spaces are located near the Bad Axe Area District Library which is located at the northwest corner of the park. These accessible spots are accompanied by ramps that allow for access to the park's asphalt and concrete sidewalks.







At the bottom of this north rectangle there are two tennis/racket ball courts. These courts have a lighting system to keep the site bright for players along with benches for resting.





The southern portion of the Bad Axe City Park is less dense but has unique infrastructure for community members. Within a large, mowed field there is a splash pad with a few water features and toys. This section strengthens this park's appeal to young families and pet owners. This field also has a skate park which serves as a gathering area for Bad Axe's youth and young adult population. At the far region of this field there is a path that connects to a 0.7-mile asphalt loop through a semi wooden portion of the city.











As explored above, the Bad Axe City Park has a range of different attractions for community members. Its location, features, and environment provided recreational opportunities for many different types of community members. This park is a great example of what community parks should provide for a city. However, there is always room for improvement. Activities such as repainting the parking stripes and playground mulch are good examples. Another possible improvement would be the addition of screening between the park and the industrial zone immediately adjacent.





Mega Courts

The Mage Courts and the Bad Axe City Park are adjacent to each other, as seen in the previous map and in many ways are a recreational unit. The two parks are separated by the S Hanselman St, with the city park and parking on the east side. This facility is categorized as a special use park due to its seasonal sporting focus. There are 6 **ball diamonds**, two are full sized and four that share outfields with each other. These diamonds are each accompanied by a set of stands, protective fencing, lighting, and two dugouts. There are two pitching enclosures and score boards that serve the diamonds during the community different baseball leagues.

Mega Courts has the following features:

- 4 softball diamonds
- 2 baseball diamonds
- 10 basketball hoops
- Concession/Storage building
- Pioneer Log Village that includes a blacksmith shop, general store, country school, chapel, family home, and barn. The facility is owned and operated by the Bad Axe Historical Society.











The Mega Courts also have **5 basketball courts** for the community member of Bad Axe to utilize. These courts areas overlap each other in an effective manner shown in the images below. Each basketball court has two baskets, markings, and lighting. The basketball and baseball portion of this park are connected to each other, parking, and the road with concrete sidewalks.









This park attracts a large amount of people during the baseball and basketball seasons. To accommodate this the park has two different **restroom** buildings and at least one porta potty. The eastern restroom building is near the basketball courts, while the western restroom building is between the 6 baseball diamonds and has a **concession stand**.









Pioneer Log Village is located in the northeast corner of the park, adjacent to the basketball courts, and the softball diamonds. It includes a blacksmith shop, general store, country school, chapel, family home, and barn. The facility is owned and operated by the Bad Axe Historical Society.

















This special use park is outfitted with many different features that support a community's desire for seasonal sporting events and other enjoyment. Its size suggests that the community of Bad Axe has considerable need for special use parks. The condition of this park similarly reflects this amount of use.



Wilcox Park

This park is located in the northeast portion of the City of Bad Axe and it is situated near residential and industrial zones. This facility is boarded by the Bad Axe Creek to the north as seen in the previous map. Considering its proximity to neighborhoods and the diverse recreational infrastructure, Wilcox Park is categorized as the city's second community park. Within the park is the Wilcox **Community Center** that is an event center. The space is available to rent for small or large groups, providing access to the inside of the building on the property. This indoor activity space offers community members the option to use city owned spaces for reunions, parties, and other group events. Both the indoor and outdoor portions of the park utilize a parking lot with 36 parking spaces. It has 2 barrier-free parking spaces and a drop-off loop. The parking lot also has a porta potty available for visitors utilizing the outside areas.

Wilcox Park has the following features:

- Nature trail through the woods
- Picnic pavilion
- Horseshoes
- Playground
- Sand volleyball
- Community Center/Multi-purpose building





This park's outdoor public space has many different types of recreational opportunities. There is a large, mowed field behind the community center that hosts a large pavilion, picnic areas and playground equipment. This picnic area is equipped with grills, tables, and lighting. There is a good range of play equipment that is throughout the field.















Wilcox Park has a large enough field to include a sand pit and a sand volleyball court.





This park has appealing natural features such as large trees and the adjacent Bad Axe Creek. The trees provide some shade for benches placed throughout the field. There is also a pedestrian bridge that visitors can use to cross over the creek and back.





As presented, Wilcox Park plays a role in the recreation of the surrounding community. It has a private indoor event space as well as an engaging outdoor space. This location is ideal for the City of Bad Axe considering that it offers the northern residential areas closer recreational opportunities.





School Recreational Facilities


In addition to the City recreation facilities, there are public and private schools with recreation facilities located in and around the region. They are briefly described as follows.

Public Schools

The Bad Axe Public Schools provide public education to the residents of Bad Axe. This system has 3 schools with a total enrollment in 2022 of 887 students. These three schools are all on a 77-acre plot in the northwestern region of the City of Bad Axe. The schools share recreational facilities such as the ones listed below.

Regional Recreational Facilities

The following facilities are located within Huron County, the region surrounding the City of Bad Axe. This county has a significant number of recreational facilities. This is, in part, due to Huron County's extensive shoreline.

Huron Community Fairgrounds (within 10-mile radius of Bad Axe)

Due to this city serving as county seat, the regional county fair association is in the southwest region of Bad Axe. This regional committee is sponsored by businesses and runs the 50 arc fairgrounds. These fairgrounds are used in regional engagement events. These events generally reflect the region's culture, such as having agricultural and family-friendly themes.

Sanilac Petroglyphs Historic State Park (within 10-mile radius of Bad Axe)

This historic park is nearly 10 miles outside of Bad Axe. It is an educational and recreational opportunity for Bad Axe and Huron County residents. This park serves to preserve and interpret Michigan's largest known collection of early Native American teachings carved in stone. This park has hiking trails connecting the carvings as well as the north branch of the Cass River.

The following chart includes the two facilities mentioned directly above, along with other recreational facilities in the region. Along with the facility's address, it lists the amenities of each along with it's association, if applicable.

Barrier Free Evaluation & Universal Design

The ultimate goal is to provide recreation opportunities that include everyone. With the passage of the Americans with Disabilities Act of 1990 (ADA), all areas of public service and accommodation are subject to barrier-free requirements, including parks and recreation facilities and programs. This planning process should include methods to ensure that the City park and recreation system is accessible to people with disabilities. The City completed an evaluation of existing facilities in 2010 to determine if they are barrier-free.

When looking at areas to determine their accessibility to all people, we started by asking these simple questions:

Can a person who has a sight or hearing disability, uses a wheelchair, uses a walking aid such as crutches or braces, has a mental disability that affects learning and understanding, safely and independently:

- Get from the arrival place to the activity area?
- How can this barrier be removed?

Do what others do in the area?

If not, what is getting in the way?

Move around the area?

Universal Access

Another often overlooked category is Universal Access. This practice goes way beyond typical Americans with Disabilities Act (ADA) regulations to practice "common and equal experiences for all." The goal of universal access is, throughout concept and design phases, to incorporate technology, materials and other considerations that promote equal opportunities for people of varied abilities. The appendix provides universal access design considerations for different types of recreational facilities. These concepts should be kept in the forefront as a prime consideration in the 5-year Master Plan and individual parks or projects as they develop and progress.

Common components that need to be looked at to answer these basic questions include parking, paths of travel from parking, street or sidewalk to activity areas, the activity areas themselves, signage, support facilities such as restrooms, surfacing, and communications required for recreation programs and general use of a facility or area. The existing parks were evaluated on the following criteria and scored 1-5.

- 5 Facility is fully accessible. Features and facilities meet and exceed the Uniform Building Code and take into consideration Universal Design principles. Main elements such as the washrooms, entrances, parking, and amenities are barrier free.
- 4 Majority of the facility is accessible; however, there are some accessibility barriers. Some improvements are needed to make the facility fully accessible.
- 3 Facility is partially accessible. Barriers exist to fully accessing the facility and an alternate facility may be necessary.
- 2 Facility has limited accessibility. Multiple barriers exist to fully accessing the facility and an alternate facility may be necessary.
- 1 Facility has poor accessibility. Accessibility barriers may exist at entranceway, recreation area

Each City Park is given their respective accessibility ranking on the previous chart on page 12.

Past Grant Status

The City of Bad Axe has not received any grant funding from the MDNR, however in the past the City has applied for two Trust Fund grants but have subsequently withdrawn both applications. The grants were for the years 1992 and 1996. The 1992 acquisition grant was withdrawn because the landowner donated the property to the City. The 1996 grant was withdrawn because of turnover on the City Council.





Natural Resource Inventory


When studying parks and recreation resources in a community, it can be worthwhile examining significant natural resources that may be in need of conservation or protection. The map below illustrates the woodlands, wetlands, and waterways in the City of Bad Axe.

Woodlands & Wetlands

The most significant natural resources in Bad Axe are the pockets of woodlands and wetlands scattered across the city.

These natural areas are dispersed throughout Bad Axe; however, the largest stands are located in the southern half and the northernmost section of the City. Several of these areas are a mixture of both wetlands and woodlands. These are areas that may provide recreational opportunities in the future. An example of woodlands that are worthy of conservation is the stand located in Wilcox Park. This provides park visitors with more recreation opportunities, wildlife viewing, and walking areas.

Wetlands are vital to the ecological health of a region as they host critical habitat for fish and waterfowl. According to EGLE wetlands map, Huron county currently has a total of 31,972 acres of wetland. This makes up about 6% of the county's total acreage. This map allows for closer examination of Bad Axe itself, which shows a lack of wetlands within the city limit. However, there is a considerable band of wetlands south of the city's borders, according to both the NWI and MIRIS maps.



Topography & Landforms

The slope of land plays an important role in determining the suitable use and development of property. Moderate slopes (10% - 25%) and areas of extreme slope (25% or more) may limit higher density developments from occurring. These limitations include a heightened risk of erosion and the difficulty in installing private septic systems. However, areas consisting of moderate and extreme slopes are very sparse within the city. It consists of fairly level terrain which presents little to no restrictions for future development.

Prior to park & recreation development, the Michigan Department of Natural Resources (MDNR) should be consulted to review the results of a wetlands determination. The impacts of development within wetland areas should be carefully considered, and a permit from the MDNR should always be obtained if regulated wetlands are to be impacted.

Soils

Soil exploration can offer key insights into a region's geological characteristics such as soil properties and distributions. This data relates closely to the region's agricultural productivity. According to Bad Axe's USDA custom soil resource report, this region of Michigan has a diverse distribution of loamy soils. This is to be expected considering the state's glacial history, with much of the lower peninsula maintaining a surface mix of sand, silt, and clay surface. Three types of loamy soil each make up 12-13% of Bad Axe's total soil distribution, Kilmanagh, Belleville, and Shebeon. Loam is so prevalent that it is earliest to identify a few outliers such as 3 types of muck and 5 types of sand.

Ultimately these results suggest that Bad Axe is a community with high agricultural potential due to it's abundance of loamy soils. These types of soil are known to have favorable conditions for crops such as air circulation, moisture retention, and non-dense textures.



Water Resources & Drainage

Bad Axe Is surrounded by beautiful lakes, rivers, and reservoirs. In addition, small portions of the Bad Axe Drain run across the northern portion of the city, providing a water feature for the community. This is shown on the map above.

Description of Planning and Public Input Process

Planning Methods

Community recreational facilities cannot be effectively provided without some basis from which the type, quantity, location, need, and priority for that facility has been determined. Several methods for determining a community's recreation needs and priorities have been identified. These include observed use levels for existing facilities, comparisons of recreational facilities between similar communities, unique opportunities for certain types of facilities, guidelines or standards based on quantity per population, and projected population growth, to identify a few methods.

Existing recreation opportunities can be compared to recreation standards to determine deficiencies. However, great care must be taken to apply common sense and knowledge of the community. These standards will be used only in conjunction with other methods to determine recreation deficiencies and priorities.

The foundation for the development of the City of Bad Axe Parks and Recreation Plan was based on the following goals:

- Involve the community in the process to develop a Five-Year Recreation Master Plan.
- Inventory and map existing Bad Axe recreational facilities.
- Build a strong foundation of Bad Axe area stakeholders in addressing the future Recreational needs and priorities of the Community.
- Enable the City of Bad Axe to be eligible for financial assistance based upon the Recreation Plan.
- Facilitate interagency collaboration in establishing recreation goals objectives and actions.
- Continue to support and implement improvements for barrier–free Universal Access to Bad Axe area parks.
- Consistency with and expansion upon goals and objectives set forth in existing planning documents that deal partially or wholly with recreation.

Public Input

Citizens' opinions on recreation priorities is a key consideration in plan development. It is important to involve the public early in the process, through public meetings, surveys, or other means. Early citizen involvement not only helps in defining needs and priorities, but it also keeps the public informed about what is going on. This in turn helps to build support and to avoid unnecessary controversy as well as eliminating unnecessary or poorly planned expenditures.

For this recreation plan the Commission offered many opportunities for public participation prior to adoption of this plan, and in a variety of ways. First, a public survey was developed that consisted of (24) questions related to current parks, improvements, and new facilities. Second, a public engagement event was held on June 12, 2025, to inform the public and gather their comments by way of planning activities. Third, the draft plan was presented at a regularly scheduled meeting of the City Council on January 5, 2025 during a public hearing. The public was also notified of the 30-day review period in which they could review the plan and make comments prior to adoption. A copy of the draft plan was also posted on the City's website, and a paper copy was available at City Hall. Lastly, the final plan was presented to the Parks and Recreation Commission and to the City Council for final adoption on January 19, 2025.



Survey Questionnaire

A survey questionnaire was developed to gain the public's thoughts related to current recreation facilities and improvements they would like to see. The survey also included questions related to where they live in the community, what type of activities they participate in, and what type of new facilities they would like. The commission reviewed and commented on the questionnaire before making it available to the public. The survey was created in electronic format for ease of tabulation and distributed by way of social media. A link to the survey was posted on the City's website and City Hall. It was available to the public from June 1, 2025, to October 1, 2025. Paper copies of the survey were also available at City Hall, at the public workshop, and the QR code for the survey was printed on Postcards, that were also available at the public workshop and placed in the lobby of City Hall. Results of the survey are discussed in the Action Program section and provided in Appendix B.

Visioning/Public Workshops

An announcement of the community event was posted on the city website (see appendix for public notice announcements). It was on June 12, 2025, from 5-7pm at Bad Axe City Park, behind City Hall. It was held at the Main Pavilion.

Informational display boards were set up, and a presentation was made to inform the attendees of the purpose for this project, and the process involved. There were three planning activities as follows to engage public participation.



Activity 1 – Elements

- Prioritizing the recreational uses and activities that are currently offered. Attendees were shown

 (3) display boards, one board for each park. They showed the parks' current amenities.
 Participants were asked to select their favorite feature from each of the City's three parks. The following were the top three.
 - Baseball/Softball at Megaparks
 - o Pavilion at Wilcox Park
 - Playground at City Park









Activity 2 – Amenities and Activities

- Attendees were shown (3) additional display boards with eight different visioning categories for the park amenities, each having different options. Participants were asked to select their favorites from the options shown. Results of this exercise showed the six highest potential amenities as follows, listed highest to lowest.
 - Sports Activities:
 - Pickleball
 - Frisbee Golf
 - Cross Country Skiing.
 - Recreational Features:
 - Playgrounds
 - Dog park
 - Boardwalks/trails.
 - o Park Amenities:
 - Pedestrian level site lighting
 - Traditional benches and seating opportunities
 - Fire pits/campfire areas
 - Traditional/rustic style pavilions and restroom facilities
 - Simple shade sails over play and picnic areas









A natural, relaxed discussion occurred between the participants as they were evaluating the display boards and contemplating their choices. From the two activities mentioned above, an actions list was created to then be implemented into the Goals and Objectives section of this plan. These actions are the specific steps that can be taken towards the goals that the community has established.

Lastly, participants were given a paper copy of the survey to complete, if they hadn't already participated online. There was also a QR code on a card to take home, if they wished to complete it later.





Other Public Engagement

To gain additional input from the community, the display boards were placed inside the lobby at City of Bad Axe City Hall located at 300 E. Huron, Bad Axe, MI 48413, to continue to get input 8 am -4 pm, Monday thru Friday. These were available to the public until October 1, 2025.









Goals and Objectives

In defining the action program, the formulation of community goals and objectives for the provision of recreation is a vital component. The goals and objectives represent the purposes for a community's role in providing recreation to its residents as well as outlining the direction that the community's effort should take in the long term. Goals are the general targets for which a community aims for while objectives are the specific steps that can be taken towards reaching that goal. A recreation plan identifies those actions that can be undertaken to implement the objectives and fulfill the community's goals.

The goals and objectives for the City in meeting the recreation needs of residents are outlined below.

Goal 1

Continue to provide and improve recreational and support facilities that inspire community pride and are functional for a variety of uses and ages.

The citizens are proud of their existing park facilities. The City wishes to continue to maintain and improve these facilities so as to improve the quality of life for residents.

Objectives

- 1. Explore partnerships, grants, foundations and other funding opportunities.
- 2. Continue to add amenities to Bad Axe park facilities based upon community input and need.
- 3. Provide recreational opportunities for people with disabilities.
- 4. Ensure that improvements and upgrades to park facilities are handicapped-accessible, where feasible.
- 5. Look at new amenities to satisfy various age groups.
- 6. Identify the best location for future dog park.
- Ensure public parks are safe and secure.

Goal 2

Provide quality leisure time activities with special consideration given to activities improving health and fitness.

Health and wellbeing are an important component of one's quality of life. Bad Axe can use its parks and recreation facilities and staff resources to offer activities and programs that will improve the health and fitness of its citizens.

Objectives

- 1. Provide both passive and active programming for a variety of ages and abilities of the population.
- 2. Continue to work with existing recreation partners in the community to provide programs, leagues, and special events. Explore options for new and expanded partnerships to provide additional recreational opportunities.

Goal 3

Provide non-motorized pathways and bicycle routes for recreational and transportation use.



Pathways and bike routes are important for the residents of the City of Bad Axe. They were mentioned frequently by survey respondents as an improvement they would like added to the City. This is a component of a parks system that can be used by people of all ages and abilities. The City plans to look into ways to extend the existing walkway and path system.

Objectives

- 1. Develop a biking network throughout the City.
- 2. Extend and add walking and multi-use paths within existing parks.
- 3. Improve path surfaces when appropriate.

Goal 4

Retain public land and conserve natural resources for future generations.

The citizens of Bad Axe wish to see their current parks maintained and kept for the future. Additional parkland may be needed in the future to accommodate the recreational needs of the community.

Objectives

- 1. Retain existing parkland and acquire new public lands to meet the recreational needs of the community.
- 2. Preserve and protect open space and other important natural features in Bad Axe.

Goal 5

Create community awareness of Bad Axe recreational opportunities and promote them to citizens and visitors.

Communicating with the public is an important component of any municipal parks and recreation organization. As our population increasingly relies on the Internet for information, the City needs to take advantage of online opportunities to communicate and interact with citizens.

Objectives

- 1. Work with local arts and culture organizations to provide unique programming opportunities at the City's recreational sites and other venues.
- 2. Work on Facebook, Snapchat, web site, and develop other online opportunities to communicate with the public about Bad Axe Park facilities and events.

Goal 6

Develop a system of park facilities that promotes four-season use.

Objectives

Provide residents with opportunities for recreation that provide multiple seasons of use within the City and the respective park facilities.

Potential Actions

- Construct compatible yet diverse uses within the parks that promote spring, summer, fall and winter uses.
- Explore options for all-season facilities such as warming shelters and restrooms in the parks as appropriate.
- Review options for winter ice skating area.



Goal 7

Continue the improvement and development of Universal Design Concepts at any and all city park locations in accordance with the park's development master plan.

Objectives:

Develop new and expanded facilities and programs at the park including new restrooms, picnic facilities, paved parking, walking paths, new play equipment and lighting.

Potential Actions

- Improve restroom facilities.
- Provide for universally accessible play areas, picnic facilities and shelters
- Provide paved parking areas and trails to provide barrier-free access to all areas.
- Provide additional non-motorized trails to better connect community destinations and areas.
- Improve signage for any visually or physically impaired park users

Goal 8

Create new partnerships and collaboration.

Objectives

As Michigan continues to struggle it is important to take advantage of collaborations and partnerships as a cost-effective way to offer recreational programs in the community.

Potential Actions

- Encourage the cooperation and participation of adjacent communities in the formation of a regional recreational advisory board in an effort to combine resources and avoid duplication of facilities and services.
- Utilize public and private sector cooperation in the promotion of recreation and the improvement of recreational opportunities.
- Encourage the participation of volunteers in the development of recreational facilities.



Action Program

A variety of factors, including community characteristics, population trends, existing recreation facilities, and identified recreation needs, contribute to the formulation of specific recommendations for plan implementation. These specific recommendations represent the actions that can be undertaken to achieve the objectives that have been directed towards a community's recreation goals. These recommended actions also represent the substance and purpose of a recreation plan - the development of a strategy for effectively closing the gap between existing recreation opportunities and recreation needs.

Recommended Actions

The community input sessions identified in the description of the planning process as well as feedback from the community on-line survey offered many insights into the priorities for recreation development. Results from the survey identified several clear thoughts and perceptions about the existing City park's structure. These results help shape the recommendations for the Action Program for future improvement and development. A complete copy of the survey results and public input sessions are included in the appendix of this plan. A summary of highlights is as follows:

- Most parkgoers agreed that they liked the overall character of the parks, but as a whole new
 uses and amenities need to be developed to meet the changing recreational needs of the
 community
- Both active and passive recreational opportunities were important to address parkgoers' desires
 and needs, and most overwhelmingly agreed that the park's overall conditions were only fair to
 good.
- While City Park was the most utilized, Wilcox Park fell short of its potential use.
- From the tallied results, the number one desired amenity is a formal skate park to be developed at City Park.
- Second most desired improvement is a more robust program of non-recreational events in the parks, such as music events, festivals, movie nights, etc.
- The third most important improvement would be the provision of newer play equipment at both City and Wilcox parks, with special attention paid to younger children.

Specific recommendations for each of the City's three major parks are as follows.

City Park

- 2026 scheduled improvements include new pickleball courts and trail extension through the park.
- · New, formal concrete skate park with lighting and cameras
- New restroom facilities
- Improved maintenance program and ADA accessibility improvements.
- Younger children/toddler friendly play equipment.

Wilcox Park

- Improved and new play equipment
- Formal nature trails with amenities such as benches, interpretive signage, focal points.
- New restroom facilities



Mega Courts

- · Court resurfacing, new nets and hoops
- Improved maintenance

In instances of emerging areas of recreational needs, such as the development of non-motorized trails, it is logical to expect that the project limits will need to be established by the identification of key connection points that should not be excluded or limited by geo-political boundaries.

The following recommendation and capital improvement schedule outlines and assigns relative priorities to activities and projects that can be implemented in both the short-term and long-range future to improve recreational opportunities in the City. Those activities and projects that can be undertaken during the five-year planning period (2026-2030) have been summarized in a Capital Improvement Program Schedule. This schedule includes cost estimates as well as possible funding sources for each suggested project.

While these projects are recommended for implementation during the planning period, they are highly dependent upon financial and administrative feasibility. It is also suggested that the City take advantage of any unscheduled opportunities that may arise. Such opportunities can be evaluated and included in this plan as an amendment to the schedule.

Financing

To accomplish the above goals, financing is imperative! The City's general fund has been the primary source of funds for operating and maintaining its current facilities. Future site improvements, acquisition, and development will remain dependent on these tax-supported funds, as will the continued operation and maintenance of these facilities unless other means are found for the funding of these items.

There are a variety of ways to pursue funding of parks and recreation projects. They include the community's general funds, donations and gifts, Multi-Jurisdictional Funding, Non-Local Financial Assistance (programs through state and federal), and millages. All of these options are discussed in more detail in the Appendix Section of this plan, labeled 'Financing Mechanisms' in Appendix A.

Universal & Accessibility Guidelines

The goal of universal access is, throughout concept and design phases, to incorporate technology, materials and other considerations that promote equal opportunities for people of varied abilities. The following table provides universal access design considerations for different types of recreational facilities. These concepts should be kept in the forefront as a prime consideration in the 5-year Master Plan and individual parks or projects as they develop and progress.

The main difference between the ADA (Americans with Disabilities Act) and universal design is that the ADA is a legal framework that sets specific accessibility standards, while universal design is a design philosophy aimed at creating environments usable by everyone, regardless of ability.

Understanding the ADA

- **Legislation**: The ADA is a federal law enacted in 1990 that prohibits discrimination against individuals with disabilities. It establishes specific requirements for accessibility in public spaces, workplaces, and transportation.
- Minimum Standards: The ADA outlines minimum accessibility standards, such as the 2010 ADA Standards for Accessible Design, which must be met by public accommodations and commercial facilities. However, it does not apply to private residences.
- **Focus on Rights**: The ADA focuses on protecting the civil rights of people with disabilities, ensuring they have equal access to public services and facilities.

Understanding Universal Design

- **Design Philosophy**: Universal design is a broader concept that aims to create products, environments, and services that are usable by the widest range of people, regardless of age, ability, or status.
- Inclusive Approach: Unlike the ADA, which may allow for segregated solutions (e.g., separate facilities for people with disabilities), universal design seeks to eliminate barriers for all users without the need for specialized adaptations.
- **Application**: Universal design principles can be applied to various domains, including architecture, product design, and digital interfaces, making them more user-friendly for everyone.
- **Universal Design**: Evolved from accessible design to address needs not covered by the ADA, recognizes a wider spectrum of abilities to create things that are easier for everyone to use, and includes the full spectrum of human motion.

Key Takeaways

Financing Mechanisms

The following paragraphs briefly outline existing sources of funds for financing the future recreational improvements in the City.

1. General Funds

The City's general fund is usually the primary source of funds for operating and maintaining their current facilities. Future site improvements, acquisition, and development will remain dependent on these tax-supported funds, as will the continued operation and maintenance of these facilities. Consequently, recreation planning has to be coordinated with the yearly budgeting process for the City's general funds.

2. Donations and Gifts

The availability of donated land, labor, equipment, and funds from individuals and organizations is an attractive and effective way to improve recreational opportunities in The City. Over the past few years, several groups and individuals have contributed significantly. Such support should be encouraged to continue.

3. Multi-jurisdictional Funding

One of the primary goals of establishing a trail authority comprised of adjacent townships would be to establish a joint source of funding for acquisition, development and maintenance of multi-jurisdictional trail projects. It is too premature to discuss levels or formulas for financial participation/contribution, but by forming such a coalition, the individual townships will collectively be in a stronger position in seeking future matching grants than if pursuing projects individually.

4. Non-Local Financial Assistance

Many communities seek outside sources of funds to supplement their local sources when providing recreational improvements. There are several programs administered by the Michigan Department of Natural Resources (MDNR) that can provide some financial assistance to local recreation projects. Funding amounts available to communities vary from year to year depending on Federal support and State legislative agendas.

The **Transportation Alternatives Program** (TAP) is a competitive grant program administered by the Michigan Department of Transportation that funds projects such as nonmotorized paths, streetscapes, and historic preservation of transportation facilities that enhance Michigan's intermodal transportation system and provide safe alternative transportation options. These investments support place-based economic development

by offering transportation choices, promoting walkability and improving the quality of life. The program uses Federal Transportation Funds designated by Congress for these types of activities. Some key information on the TA program is as follows:

- Funding with be reduced from the current \$23 million a year to \$14-16 million a year. Project funding will be more competitive than previously with the average per capita award in the \$44-50 per person range.
- Minimum match is still 20% however historic average is 34% and the 2011 average was 44% local match to grant. Any project request for over \$2,000,000 total project cost must be 50%-50%. The most favorable grant request will likely be in the \$500,000 range.
- Regional Trails will still be a priority, as will urban area streetscapes. Museums and historic preservation projects will be phased out for funding consideration.
- Preliminary grant application review with regional staff is encouraged to determine competitive nature of project and gather suggestions from TE staff. Project narratives should focus on intermodal transportation opportunities as they relate to the larger picture in the community, traffic calming, improving safety and improving water quality through best management practices.

The **Michigan Natural Resources Trust Fund** (MNRTF) is administered by the MDNR. The MNRTF program utilizes the royalties from oil, gas, and other mineral developments on state-owned lands to help finance the acquisition and the development of outdoor recreation facilities. The CMI program is the result of the passage of Proposal C of 1998.

Any unit of government, including school districts, may apply for grants to develop or acquire land(s) for public recreation or resource protection purposes. Application forms are available on February 1 of each year. The application deadlines are April 1 and September 1, of each year. The MDNR submits a list of recommended projects to the legislature the following January and funds are available after legislative appropriation, usually the following fall.

All local units of government must provide a local match of at least 25 percent of total project costs. For **MNRTF** development projects, the minimum funding request is \$15,000, and the maximum is \$300,000. Proposals must be for outdoor recreation or resource protection purposes. Outdoor recreation support buildings and other facilities are eligible for development funding, as is the renovation of existing recreation facilities.

All applicants must have a current DNR-approved community recreation plan, documenting the need for project proposal.

In addition, any private individual may <u>nominate</u> land for public acquisition under this program. All nominations are reviewed by the MDNR for possible acquisition and the landowner is not required to be the person nominating a parcel of land for public acquisition. <u>Nomination forms</u> are available at any time from the DNR Recreation Division and may be submitted to the Department year-round.

The Federal Land and Water Conservation Fund (**LWCF**) program makes money available to the States for land acquisition and development of outdoor recreation facilities. From 1965 to 1996, the Department of Natural Resources (DNR) received over \$100 million in LWCF assistance for more than 1,500 projects, over 1,100 of which have been grants to local governments. The objective is to provide grants to local units of government and to the State to acquire and develop land for outdoor recreation.

Applications are evaluated on established criteria including project need, capability of applicant, and site and project quality. At least 50 percent match on either acquisition or development projects is required from local government applicants with a \$30,000 minimum and \$100,000 maximum funding limit. The Michigan Department of Natural Resources (MDNR) makes recommendations to the National Park Service (NPS), which grants final approval. Criteria are spelled out in the "Recreation Grants Selection Process" booklet given to all applicants.

PA 32 of 2010 created the Local Public Recreation Facilities Fund to be used for the development of public recreation facilities for local units of government. Money for this fund is derived from the sale of the **Recreation Passport** which replaces the resident Motor Vehicle Permit (MVP) — or window sticker — for state park entrance. The passport will be required for entry to state parks, recreation areas and boating access sites. Ten percent of remaining revenue will be used to fund the **Recreation Passport local grant program**. A 25% minimum local match is required for the Passport grant program with a maximum grant amount of \$150,000 and a minimum of \$7,500.

The grant program may only be used for local development projects. The program is focused on renovating and improving existing parks, but the development of new parks is eligible. In addition, projects must fulfill the following requirements in order to be eligible:

• Current annual capital improvement plan (CIP) – plan must include the proposed project. If your community does not have a CIP, you must have a current approved recreation plan on file with the DNR.

Organizations with an interest in developing fishing conditions in their areas may be able to get financial assistance from a program established through the **State Game and Fish Protection Fund**.

This fishing development grant is offered through the MDNR and can be as much as \$200,000 annually, in cash or in-kind services. Projects eligible for funding include: culvert modifications for improved stream flow; livestock or sheet erosion control projects; the development of spawning riffles, fish cover structures, or spawning reefs; and the construction of fishing piers and rough fish barriers.

The MDNR accepts grant proposals from organized fishing groups and local units of government. In all cases, projects are able to approach other sources such as the federal government for additional matching funds.

The *Historic Preservation Grant Program* is administered by the Department of State with funds made available through the National Park Service of the Department of Interior. The intent of the program is to conduct surveys of architectural, engineering, archaeological, and historic resources, to identify and nominate eligible properties to the National Register of Historic Places, and to plan for the protection of those cultural/recreational resources.

The funds for this program are apportioned by the National Park Service directly to the State, which, in turn, allocates funds on a project-by-project basis to local governments, organizations, and individuals.

In Michigan the Historic Preservation Grant program is administered by the Michigan Department of State. The amount of assistance is up to 50% of the project expenses. Grantees are reimbursed at the completion of the project for work done within the days of a contract between the Department of State and the grantee. EXPENSES INCURRED PRIOR TO THE EXECUTION OF A CONTRACT ARE NOT ALLOWABLE PROJECT COSTS AND WILL NOT BE REIMBURSED.

The **Inland Fisheries Grant Program** offers grants up to \$30,000 for projects that enhance the state's aquatic resources. This program may be applicable to the scenic overlook fishing platforms and educational kiosks.

The City is committed to reviewing all available funding sources and preparing the necessary plans, reports, cost estimates, and funding applications, to achieve the goals of this recreation plan.

Waterways Program Grants are funded through the Michigan State Waterways Fund from state marine fuel tax and watercraft registrations. By law, administration of the Waterways Program is through the Michigan Department of Natural Resources (DNR) and overseen by the Department's Parks and Recreation Division.

Grants provide funding assistance for design/engineering and construction of public recreational harbor/marina and boating access site/launch facilities throughout the state. Only local units of government (city, village, township, or county) and public universities are eligible. Applicants may cooperate with community/sports organizations in the implementation of projects. On-site investigation by DNR, Parks and Recreation Division staff may be required to determine suitability of proposed work. Applicant may also be required to document area boating demand. Greater priority may be given to projects for which a local applicant documents match capabilities equal to or greater than the percentage of project cost they are required to provide. The local match can include inkind expenses as long as they are well-documented.

Applications, and all required information, must be received by 5:00 p.m., **April 1st.** If April 1st falls on a weekend, the deadline would be the last State working day prior to April 1st. The application review and funding process for projects is from April 1st until an appropriation is approved by the Legislature. This can take up to 18 to 24 months. Notification of approval for engineering and smaller sized construction projects may occur within six months after completed application form and proper documentation are received. Funding for construction is not released until permits are secured.

Communities, non-profits, and municipalities can submit projects by applying for a **Patronicity Crowdgranting Campaign**. Crowdgranting is the effort of leveraging broad based crowdfunding against a sponsor's matching grant to improve communities.

- Any other place based (or public space improvement) project

The Public Spaces, Community Places program is a public placemaking initiative created by the Michigan Economic Development Corporation. Projects that meet the program's


parameters and successfully crowdfund their goal will receive a matching grant from the MEDC of up to \$50,000.

5. Millage

In an effort to raise matching funds or fund projects with local money, many community leaders have placed ballot proposals before their residents for a dedicated increase in their existing mill property tax to fund park maintenance and repair, including care for new parks and newly acquired parks, compliance with the Americans with Disabilities Act (ADA), as well as safety and security improvements. Establishment of a Park Improvement/Development, Maintenance and Repair Millage will ensure that parks and facilities will be maintained at the level of quality expected by park users and that new parkland will have adequate amenities.






Q3 Are your primary recreational activities passive or active?


Q4 Generally, when would you use recreational facilities?


Q5 What would you rate the overall condition of the parks in the City?


Q6 How often did you utilize the various parks/facilities in the City in the past 12 months?







Q7 In order of 1st highest use, which park did you attend the most?





Q8 How many times did you visit the park you used most in the City in the past 12 months?





Q9 In order of 2nd highest use, which park did you attend the 2nd most?








Q12 Based on your observations, which park is the best utilized to its fullest potential?








Q13 Based on your observations, which park is the most under-utilized and falling short of its potential?







Q15 Which park would you prefer as a venue for special events like music in the park?






Q17 Do you feel that there are adequate park facilities that you can walk, or bicycle to and not drive?




